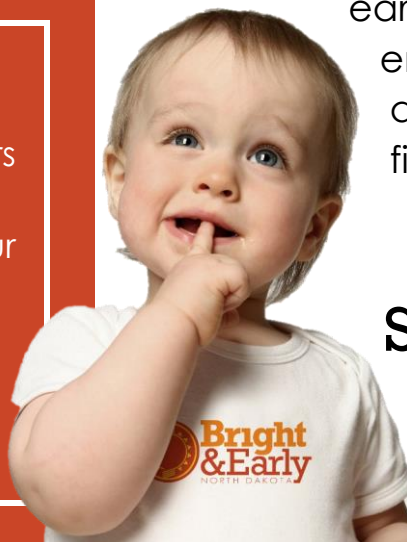

Quality Standards Update

As of July 1st, 2017 all Bright & Early ND Step 1 Quality Rated programs will be required to renew on a yearly basis. Programs that are currently holding a Step 1 Quality Rating will have until December 31st, 2017 to renew their Step 1 status. Curriculum Alignment

The [Curriculum Alignment Worksheet](#) is used to show how your program's curriculum aligns with the North Dakota Early Learning Guidelines. Bright & Early ND has updated this worksheet. It now encompasses all age groups in one document: Birth-5 years old. No need to fill out multiple forms! Everyone fills out the same questions, regardless of the type of curriculum they use: published, bundled, or self-designed. This is a great tool to celebrate and show off all of the amazing ways you meet the needs of the children in your care. The more you explain and show us what you do, the better understanding the team has on how you incorporate the curriculum into your program. Your coach can assist you with filling out the worksheet if you have any questions.

A long standing goal of Bright & Early ND has always been to tie higher child care assistance reimbursements to programs that showcase their quality through a Bright & Early ND Quality Rating. We are excited to announce that we were recently notified by the North Dakota's Child Care Assistance Program (CCAP) that they will be using Bright & Early ND's Quality Ratings to determine different levels of payment, in the form of a [tiered reimbursement system](#). North Dakota CCAP plans to implement tiered reimbursement within the next 1-2 years. More information will be coming soon so stay tuned!



PROFESSIONAL DEVELOPMENT

Quality Standards Update

As of July 1st, 2017 Bright & Early ND will be implementing the new Professional Development Quality Standards as outlined in the Bright & Early ND [Playbook](#). Programs applying for the July 2017 cohort and beyond and programs that are currently Quality Rated will need to meet the new Quality Standards.

Programs can use the Professional Development Quality Standards Inventory as a resource and guide. This inventory will help your program meet the requirements needed for each Quality Rating Step and plan future training Opportunities.
